Members are required to renew their membership for 2018 to:

- Members must swipe their current 2018 Panthers membership card.

Must renew or become financial member for 2018 before 8.55pm, Saturday 28 October 2017.

- Promotion is open to renewing members, new members, life members and permanent members.
- Upon swiping their current 2018 Panthers membership card from 9am to 8.55pm Saturday 28 October 2017, members will receive a **virtual ticket** into the 'Panthers Group \$30,000 Draw' promotion.
- Virtual tickets will automatically be entered into the 'Panthers Group \$30,000 Draw'.
- The virtual entry barrels will close at all club locations at 8.55pm
- The virtual draw barrels from each Club will be used to select Five (5) finalists from each of the six (6) clubs. This will give a total of Thirty (30) finalists.

The finalist draws for each Club will take at Penrith Rugby League Club (Panthers Penrith). This will be conducted by an Operational Leader.

All finalists' information will be displayed on raffles TV and broadcast over each club's PA system

Each Club will voice over the PA system the names of the five (5) finalists for their specific Club. The

names of the thirty (30) finalists will be displayed on each Club's in-house television system.

The finalists are required to be present on the night of the draw. It is also considered valid if a member of a reciprocal club is present at another club – for example if a member of Panthers Glenbrook is present at Panthers North Richmond that is considered valid for being a finalist. The finalists have 4 (four) minutes to present themselves to their clubs promotional area.

If the finalist does not present themselves within the specified time then no further finalists will be drawn.

All details from finalists that are present across all clubs will be entered into a virtual barrel.

Between 9 & 10pm the winning draw will take place.

An Operational Leader from Panthers Penrith will conduct the virtual draw to select the winner.

The winner's name will be phoned through to the appropriate Club if the winner is not from Panthers Penrith.

The winners name will be read over all Club PA systems and will be displayed on the in house Club televisions across all Clubs.

The winner will have (4) minutes to present themselves to the Promotions desk to claim their prize.

General

1. The 'Panthers Group \$30,000 Draw' Trade Promotion is free to enter. The above 'How to Enter' criteria must be met.

3. The promotion is open to Panthers Group members who have renewed their membership at their respective Club for 2018.
4. Tickets will be considered null and void if placed into the incorrect entry barrel.
5. Members must be aged 18 years or over.
6. Members must be in possession of their current 2018 Penrith Rugby League Club membership card.
7. Panthers Group Board of Directors, Management, Staff who have been associated with the club for any time since the commencement of the promotion, are not eligible to claim any prizes on offer. Guests of members and visitors are also not eligible to enter this promotion.

- 11 If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Club, the Club reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
- 12 Entrants consent to the Promoter using their name, image and/or voice in the event that they are a winner in any media for an unlimited period of time without remuneration for the purpose of promoting this promotion (including any outcome) and/or promoting any products manufactured, distributed and/or supplied by the Promoter.
