2. Draws will be held at the Panthers Penrith (ABN 57 000 578 398) premises (123 Mulgoa Rd, Penrith), in the Promotions Desk.
3. Members can swipe their current membership cards at the kiosk to receive vouchers between 9am & 2pm every day.
4. The promotion commences Monday 22 June 2020 and concludes Friday 28 August 2020

PROMOTION ENTRY ELIGIBILITY

Entry tickets for the Daytime Delights will be issued to current financial members of Panthers Penrith with the purchase of any Daytime Delights Offer, every day, during the promotional period. This includes:

Members card is swiped

Voucher is retained by staff

TASK button is selected and once cashed off it will print an entry form for the member.

Or a \$3 Discount on any menu item from the Grill section of Kelly's menu 11 30am to 3PM

Members card is swiped

Voucher is retained by staff

TASK button is selected and once cashed off it will print an entry form for the member.

Voucher Four - \$1 off any Melt from Kelly's Café or Buy a Mug of hot beverage get a free Triple Chocolate Brownie Kelly's café.

\$1 off any Melt from Kelly's 9AM to 2:30PM or purchase a Hot beverage and get a Triple Chocolate Brownie at Kelly's Café 9am to 2 30pm.

Members card is viewed

Voucher is retained by staff

TASK button is selected and once cashed off it will print an entry form for the member.

Members will also receive 1 entry into to the draw for every \$10 spent at morning session of Bingo/Cash Housie.

Once the Daily Delights offer has been redeemed, the Member will be provided with an entry ticket until 2.55pm, which they need to place in the Entry Barrel located at Promotions area every day before 2.55pm. The Entry Ticket is only valid for that day's draw.

Entry tickets will be removed from the Barrel at the conclusion of the 3pm draws.

Members are not limited to the number of Entry tickets placed in the barrel, all entries are valid on day of issue only.

Members are not permitted to enter promotions on behalf of other Panthers Members.

DRAW PROCEDURE

4. Entry barrel will close at 2.55pm for the 3pm draw.
5. One (1) ticket will be drawn from the entry barrel for each draw and the Member's name drawn will be announced over the PA system. The winning Member must present along with their financial Membership card within four (4) minutes of the announcement to claim their spin of the **WHEEL OF CASH**.
6. The Member will be ineligible if they are not on the Club's licensed premises at the time of the draw.
7. It is the responsibility of Members to be in an area of Panthers Penrith premises where they can hear the draw announcements.
8. Members can only win once per session.

General

9. The Club collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Club, the Club reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.

Except for any liability that cannot be excluded by law, the Club (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Club's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Club) due to any reason beyond the reasonable control of the Club; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.
