

## PANTHERS PENRITH | Terms & Conditions: **Member's Mega Cash Draw**

### Conditions of Entry

1. The promotion is conducted by Panthers Penrith, under Penrith Rugby League Club Limited (ABN 57 000 578 398), herein referred to as 'the Club', of 123 Mulgoa Road, Penrith, NSW 2750. Telephone number (02) 47205555.
2. The promotion operates every **Sunday & Thursday**.
3. The promotion is open to full financial members of the Club including proposed members and excluding Social members, Directors, Management, Staff, contractors and their employees of the Club and related companies.
4. The promotion comprises: **(i) Membership Mega Cash Draw, (ii) Guaranteed Cash Draw, (iii) Second Chance Draw and (iv) Clearance Draw**
5. Draws are held at the Panthers Penrith.
6. It is the responsibility of members to be in an area of the Panthers Penrith premises where they can hear draw announcements.
7. A member must personally present their full financial membership card or photo identification to the promotion host within four (4) minutes of the announcement to claim any prize.
8. Promotion runs from Sunday 3<sup>rd</sup> September to Sunday 25<sup>th</sup> February 2024.

### **(i) Members Mega Cash Draw**

1. A Members Mega Cash Draw will take place at the Panthers Penrith premises each Sunday & Thursday of the promotion period, whereby a membership number is randomly selected from the Club membership database using IGT. Members with the home club of Penrith **only** will be enrolled into the promotion.
2. A draw is conducted at the following times:
  - a. Sunday – 5.00pm, 6.00pm and 7.00pm
  - b. Thursday – 6.30pm, 7.30pm and 8.30pm
3. The winner will be announced over the Club's PA system and has 4 minutes to claim their prize.
4. The winner must have made at least one purchase and swiped their membership card in the Club on the day of the draw (prior to the draw being announced) to be eligible to claim the prize. This will be verified through the IGT membership system.
5. The jackpot pool starts at \$15,000 and jackpots \$1,000 with every unsuccessful draw session.
6. The maximum jackpot amount will be capped at \$25,000 and must be won.

### **(ii) Guaranteed Cash Draw**

1. Sunday at 5:45, 6:00, 6:15, 6:30, 6:45, 7:00 & 7:15pm a winner will be drawn from the barrel to win \$100 cash.
2. Thursday at 6:45, 7:00, 7:15, 7:30, 7:45, 8:00 & 8:15pm a winner will be drawn from the barrel to win \$100 cash.
3. Entry in the Guaranteed Cash Draw will be gained by doing the following every Sunday & Thursday:
  - a. A member swipes at the reception kiosk - 1 ticket per day
  - b. A member purchases at Kelly's Kitchen – 1 ticket for every \$20.
  - c. A member purchases at Kelly's Bar / Lakeview Bar – 1 ticket for every \$10 spent.
  - d. A member purchases Raffle Tickets, plays Bingo or Cash Housie on any Sunday or Thursday – 1 ticket for every \$20 spent
4. All entry tickets need to be in the barrel by the time each Guaranteed Cash Draw is conducted, and it is the responsibility of the member to do so.
5. The winner will be announced over the Club's PA system and has 4 minutes to claim their prize.
6. If no winner is found, a redraw will be conducted until a winner is found.

### **(iii) Second Chance Draw**

1. After the final Members Badge Draw has been conducted at 7pm Sunday & 8.30pm Thursday a \$1,000 Second Chance Draw will take place.
2. A Second Chance Draw will **only** take place if the Membership Badge Draw is **unsuccessful after the three Membership draws on the night**.
3. The Second Chance draws winner will be drawn from the Guaranteed Cash Draw barrel.

4. All entry tickets need to be in the barrel by the time Second Chance Draw is conducted, and it is the responsibility of the member to do so.
5. The winner will be announced over the Club's PA system and has 4 minutes to claim their prize.
6. If no winner is found, a redraw will be conducted until a winner is found.

### **(iii) Clearance Draw**

1. When the jackpot reaches \$25,000, there will be one ordinary Membership Badge draw for that amount at 7pm, and if it is not won, a special Clearance Draw will take place.
2. The Clearance Draw will be conducted from the regular Second Chance Draw barrel at 8:30pm and the prize money will be broken down into smaller prize lots.
3. There will be 1x \$15,000. 2 x \$5,000
4. The winners will be announced over the Club's PA system and have 4 minutes to claim their prize.
5. If no winner is found, a redraw will be conducted until all four amounts have been claimed.
6. The Guaranteed Cash Draws **will** occur on the night of the Clearance Draw, but the Second Chance Draw **will not**.

### **General**

1. Payments up to \$2,000 will be made in cash and the balance of the prize will be in the form of a cheque that will be issued within five working days.
2. An independent scrutineer will be present for all draws of \$10,000 or more.
3. The Club collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this information. Entrants should direct any request to access, update or correct information to the Club. All entries become the property of the Club.
4. If there is a dispute as to the identity of an entrant, the Club reserves the right, in its sole discretion, to determine the identity of the entrant.
5. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Club, the Club reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
6. Except for any liability that cannot be excluded by law, the Club (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Club's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Club) due to any reason beyond the reasonable control of the Club; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.
7. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
8. Entry is open to fully financial members of the Club including proposed members and excluding Social members, Directors / those acting in office for the Club, management and employees of the Club and its related companies and its marketing agencies are not eligible to participate in the Promotion and shall be ineligible for any prize covered herein. Entrants acknowledge that the Club is not liable for reimbursement of any prizes otherwise payable to eligible entrants who are in violation of this provision.
9. The Club reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, membership status and place of residence) and to disqualify any entrant whose entry is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Club's discretion. Failure by the Club to enforce any of its rights at any stage does not constitute a waiver of those rights.
