

EAT OUT FREE FOR A YEAR - TERMS & CONDITIONS

EAT OUT FREE FOR A YEAR promotion (the Promotion) commences 10th May 2024 and runs until the 30th of June 2024.

The promotion will be held at the Panthers Penrith (ABN 57000578398) premises (123a Mulgoa Road Penrith).

'Participating outlets' – Kellys Bar + Kitchen, Osso Penrith, CJ's Crabshack, Zen Noodle Bar, Italian Street Kitchen, Chopstix or Fork, Alexanders.

PROMOTION OVERVIEW

- Members must dine out at any 4 participating outlets during the promotion period.
- Collect 4 receipts as proof of purchase from 4 different participating outlets when you dine.
