Promoter

Promotional Period

The promotional period commences on **Friday, 17 October 2025** and concludes at **11:59pm AEDT on Monday, 26 January 2026**.

Eligibility

- Entry is open to Australian residents aged **18 years and over**.
- Entrants must purchase any two products or a jug of Coca-Cola varieties from a "Participating Bar" and swipe their membership card during the "Promotional Period".
- "Participating Bars" include: Backyard Bar, The Basement Sports Bar, Alexander's, Kelly's Bar, Squires Terrace Bar, and Lakeview Bar.
- Entry is automatic upon a valid purchase and membership card swipe.
- Directors, Advisory Committee Members, employees, and immediate family members of the Promoter are **not eligible** to enter.
