

Panthers Singing Quest 2026 – Terms & Conditions

1. Promoter

The promoter is Panthers Penrith, 123 Mulgoa Road, Penrith NSW 2750 ('the Promoter').

2. Competition Dates

Heats: 24 Oct, 31 Oct, 7 Nov, 14 Nov, 21 Nov, 28 Nov 2026.

Semi Finals: 5 Dec & 12 Dec 2026.

Grand Final: 19 Dec 2026 – EVAN Theatre.

The Promoter reserves the right to amend dates if required.

3. Eligibility

- Open to Australian residents.
- Junior Category: 10–17 years.
- Open Category: 17 years and over.
- Entrants under 18 require parent/guardian consent.
- Employees, judges and immediate family may enter only with promoter approval.
- Professional recording artists under exclusive contracts may be deemed ineligible.

4. Entry

- Entry is free.
- Entries must be submitted through Skeed Entertainment.
- Entry does not guarantee selection.
- Contestant numbers are limited.
- One heat entry per contestant unless otherwise approved.

5. Performance Requirements

- Two songs performed in heats and semi-finals.
- Grand Final requirements advised to finalists.
- Contestants must provide approved backing tracks or accompaniment.
- Songs must be suitable for a family audience.

- Inappropriate performances may result in disqualification.

6. Judging

Contestants will be judged on vocal ability, stage presence, performance quality, musical interpretation and overall entertainment value. Judges' decisions are final.

7. Competition Format

Six heats, two semi-finals and one Grand Final. The Promoter may alter the format if necessary.

8. Prizes

Heat/Semi Finals:

Junior: 1st \$100, 2nd \$50.

Open: 1st \$150, 2nd \$100.

Grand Final:

Junior: 1st \$1,000, 2nd \$350, 3rd \$200.

Open: 1st \$2,500, 2nd \$750, 3rd \$400.

Additional appearance payments may apply. Prizes are not transferable.

9. Attendance

Contestants must register by the nominated time. Late arrivals may forfeit their place.

10. Behaviour

Contestants must behave respectfully. The Promoter may disqualify any contestant for inappropriate or unsafe behaviour.

11. Photography & Recording

By entering, contestants consent to being photographed and recorded. Panthers Penrith may use this material for promotional purposes without further payment.

12. Media & Publicity

Contestants agree to participate in reasonable promotional activities associated with the competition.

13. Privacy
